* Charter rate: \$1000 minimum rate includes first 50 people;
\$18/person after the minimum charge. Maximum \$1900;
* 125-passenger limit for Desert Belle Private Charters
* \$4 per person for every 30-minutes extra (minimum \$200/half hour;
Maximum \$400)

* Rates based on minimum 2 -hour charter
* City of Mesa tax rate is 6.7%
* Gratuity added at 10%
* Kids under 5 are FREE but must be accompanied by
1 adult per child.

\$250 non-refundable deposit is required to secure charter. Deposits are non-refundable and due 30 days prior to scheduled Charter time. BALANCE and EXACT NUMBER OF PASSENGERS ARE DUE SEVEN DAYS PRIOR TO CHARTER. Notice of cancellation less than seven days prior to departure will result in full forfeiture of \$250 deposit. Private Charters scheduled-cancelling a public trip- will require a \$600 non-refundable deposit. BALANCE and EXACT NUMBER OF PASSENGERS ARE DUE SEVEN DAYS PRIOR TO CHARTER. Notice of cancellation less than seven days prior to departure will result in full forfeiture of \$600 deposit. No refunds will be made for "no show" passengers. All delinquent accounts are subject to full balance plus collection fees.

Desert Belle & U.S Forest Service Policies

1. Swimming off the Desert Belle is prohibited.
2. State law requires that all children 12 years of age or under must wear a flotation device, provided by the Desert Belle.
3. Desert Belle is available 30-minutes prior to departure time for setup if necessary. Client is responsible for removal of all decorations and general cleanup within 30-minutes of charter time.
4. A CD player, MP3 adaptability, PA system and microphone are available on board.
5. Client may bring their own food on board and a \$150 charge for setup/cleanup will apply, however bringing alcohol or any other beverage on board is strictly forbidden due to licensing laws OR Client may choose to cater the event with one of the approved caterers and there is no setup/cleanup fee.
6. The Desert Belle reserves the right to cancel any charter at their discretion and may return to the dock to have any disorderly persons removed by the Sheriff's Department.
7. In the unlikely event of mechanical failure, acts of nature or disorderly conduct that requires the Desert Belle to return to the dock, Desert Belle Tours WILL NOT be held responsible for any deposit, fee or other remunerations paid by the client to caterers, musicians, entertainers or such persons.
